(b) Rescissions.—

- (1) FISCAL YEAR 2026.—For fiscal year 2026, effective on the day after the date on which appropriations are made available through the end of fiscal year 2026 for the entire Federal Government, there is rescinded, on a pro rata basis, 1 percent of the nonsecurity discretionary appropriations made available for fiscal year 2026.
- (2) FISCAL YEAR 2027.—For fiscal year 2027, effective on the day after the date on which appropriations are made available through the end of fiscal year 2027 for the entire Federal Government, there is rescinded, on a pro rata basis, 2 percent of the nonsecurity discretionary appropriations made available for such fiscal year.
- (3) Subsequent fiscal year thereafter, effective year 2028, and each fiscal year thereafter, effective on the day after the date on which appropriations are made available through the end of the applicable fiscal year for the entire Federal Government, there is rescinded, on a pro rata basis, 5 percent of the nonsecurity discretionary appropriations made available for such fiscal year.

(c) OMB REPORTS.—For fiscal year 2026, and each 1 fiscal year thereafter, not later than 30 days after the date 2 3 on which appropriations are made available through the end of such fiscal year for the entire Federal Government, 4 the Director of the Office of Management and Budget 5 shall submit to the Committee on Appropriations of the 6 7 Senate and the Committee on Appropriations of the House of Representatives a report specifying the account and 8 amount of each rescission made pursuant to subsection 9

(b).
