As a result of the ongoing emergency conditions in Tennessee from heavy rainfall and Hurricane Helene, the state of Tennessee is requesting an Emergency Declaration, Categories A and B, including Direct Federal Assistance, in order to enhance life-saving capabilities and implement needed emergency protective measures. Multiple counties in eastern Tennessee are experiencing unprecedented flooding which has resulted in the loss of major transportation infrastructure, healthcare facilities, communications infrastructure, and homes and businesses. This request for Direct Federal Assistance should be coordinated with the Tennessee Emergency Management Agency.

The remnants of tropical cyclone Helene is causing widespread damages across Tennessee, especially in the eastern portion of the State. The Unicoi County Hospital is inundated with flood waters and patients/staff are being evacuated and those evacuations are being complicated by the Nolichucky River rising rapidly with debris; local officials in Washington County have told Embreeville residents to evacuate: Hawkins County officials have told residents to shelter-in-place; and there are reports of individuals standing on roofs around Carter County. An estimated 6 to 10 inches of rain has fallen across the mountainous terrain of eastern Tennessee over the past 48 hours and the heaviest rains will shift over the middle and western Tennessee later today. As of 11:30am CDT, over 75.500 power outages were reported statewide. Rain fall is expected to continue throughout the weekend. 9. Description of the nature and amount of State and local or Indian tribal government resources which have been or will be committed. On 9/26/2024, the State Emergency Operations Center (SEOC) elevated to a Level 4 (monitoring) to prepare for potential impacts from the remnants of tropical cyclone Helene and on 9/27/2024 at 12:00pm CDT, Tennessee declared a State of Emergency and the SEOC was elevated to a Level 3 (state of emergency) due to widespread life safety needs. The SEOC is currently staffed with representatives from the TN Department of Transportation, TN Department of Human Services, American Red Cross, TN National Guard, TN Department of Safety, TN Department of General Services, TN Department of Health, FEMA Region 4 FIT, and multiple other organizations. Local, state, national guard, and out-of-state response resources, including swift water rescue teams and helicopter rescue teams, have been deployed to assist with life saving efforts. The SEOC is currently coordinating 20 active resource requests and those requests continue to grow exponentially.
